EXHIBITION INFORMATION

EXHIBITION OPENING

- The exhibition opening is the First Friday of the month from 5-7pm (unless arranged otherwise)

COMMISSION AND FEES

- A nonrefundable and nonnegotiable fee of \$ 15 dollars per entry will be charged. You may enter more than one piece, depending on wall space. Size of art work should not exceed 36" x 36". Larger sizes should be discussed before entry form has been submitted.
- Mas Art will take 5% commission from all sales.
- All sales transactions must be processed through Mas Art.

DELIVERY OF ARTWORK TO AND FROM THE GALLERY FOR EXHIBITION

- Artists are responsible for transporting their artwork to and from Mas Art. Artwork is due at Mas Art on the Monday of the exhibition week
- Art work sold or not must be picked up by Monday of the last week of show. A storage fee of \$ 20 dollars per day will be charged for art work not picked up on time.
- For liability reasons art work will not leave the store until all payments are cleared.

INSURANCE AND ARTIST RESPONSIBILITY DURING EXHIBITION

- each artist is required to Attend the opening reception on the first Friday between 5 – 7pm. Meet the Artist is a great opportunity to promote the artist and increase sales during exhibit.
- It is the artist's responsibility to arrange any artwork insurance.
- All artwork to be exhibit must be clean, and professionally mounted or framed and ready to be displayed.
- The artist is responsible for any taxes originated from sales. As a "freelancer", the artist is responsible for paying their own taxes, and own self-employment taxes. Plus, responsible to keep all the records for business including your freelance income and your freelance expenses.

MAS ART EXHIBIT RESPONSIBILITY

- Mas Art will supply the opening refreshments such as cheese/fruits and wine.
- Mas Art provides a volunteer to help at the opening services.
- Preparation and distribution of MailChimp invitation via Mas Art's emailing list and text newsletter.
- photos are taken at the opening for social media/promotion of your exhibition, Instagram and Facebook.
- The work shall remain at the store for the duration of the month. Mas Art agrees to devote its best efforts to maintain and care for the artwork: however, artist

should carry insurance adequate to cover artist's assigned value of artwork, should the artist desire such insurance. MAs Art assumes no responsibility for loss or damage sustained to art work.

- Payments of art sold will be made to the artist within a week for transactions processing. charges for checks bounced or canceled will be charged from the artist.

- Mas Art reserves the right to refuse any art work that is deemed inappropriate or fails to meet entry requirements.
